RETENTION RATE: Retention rates measure the percentage of first-time students who return to the institution to continue their studies the following fall or completed their studies within the reporting period. The Fall 2023 cohort retention rates reflect students enrolled between 8/1/2023 and 10/31/2023 who completed or were still enrolled as of 10/31/2024.

GRADUATION RATE: To calculate the completion rate, the school identifies a cohort of students each year and reviews the performance of that cohort over time, not to exceed one- and one-half times the normal course length. Ogle School used a year cohort of students who started on or after 9/1/2021 through 8/31/2022 and graduated within 150% of their normal course length. Only first- time, full-time certificate seeking students are included in the calculation.
